



Recommended Usage:

Each lot of this antibody is quality control tested by immunofluorescent staining with flow cytometric analysis. For flow cytometric staining using the microg size, the suggested use of this reagent is  $\leq 0.25$  microg per million cells in 100 microL volume. For flow cytometric staining using the microL sizes, the suggested use of this reagent is  $\leq 5$  microL per million cells or 5 microL per 100 microL of whole blood. It is recommended that the reagent be titrated for optimal performance for each application.

Syndecan-1 participates<br>in cell proliferation, cell migration, and cell matrix adhesion via interaction with<br>collagen, fibronectin, and other soluble molecules (such as FGF-basic). It is<br>expressed on normal and malignant plasma cells, pre-B cells, mesenchymal cells,<br>epithelial cells, and endothelial cells. |
